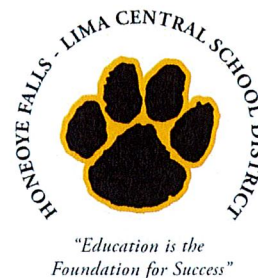

The BOCES service providers will be working closely with HF-L to review all homeschool documentation and provide families with feedback regarding compliance with the New York State Regulations. ### What does this mean for you?

- The parent/guardian is responsible for meeting all deadlines for the submission of:
  - Letter of Intent, IHIP, Quarterly Reports, and Annual Assessment.
- Please send the required documentation to HF-L and send a copy to BOCES.

- BOCES will provide you with feedback regarding the documents you submit and compliance with the NYS Regulations Part 100.10.
- After submission, you may receive some additional guidance on your reports.

If you plan to homeschool your child for the 2025-2026 school year, and you have not done so already, please send a **Letter of Intent** to the Honeoye Falls-Lima Central School District and a copy to BOCES by **July 1, 2025**.

**IHIP** (Individual Home Instruction Plan) forms are due by **August 15, 2025**. Please send a copy to HF-L and to BOCES. You may access IHIP forms at [www.monroe.edu](http://www.monroe.edu). Go to the **Departments > Homeschool Monitoring**, and choose the **Honeoye Falls-Lima Parents** link. Please scroll to the bottom to find the appropriate grade level. Alternative formats for IHIP submission are acceptable. However, all families must submit the IHIP Cover Sheet (found on the Monroe One BOCES site), along with an IHIP. Please contact BOCES if you would like hard copies of any forms sent to you.
